- Welcome and Introductions
- Approval of May 2013 General Board Meeting Minutes
- Approval of 2013/2014 Standing Rules
- Vote in Kelli Torrie as VP Programs Enrichment
- Review of the Board's Fundraising Plan copy of fundraising plan attached to minutes.
 - Kick off in October to coincide with Microsoft and Boeing Give Campaigns and will end October 31.
 - Asking for \$200 from each family (need 125 families to give \$200 in order to meet budget of \$25,000)
 - Anticipate receiving \$13,000 from other fundraising throughout the year for total budget needs.
 - Need \$38,000 next year for Science Specialist.
 - Plan going forward after the Ask is to focus on Affiliate programs (Amazon,
 PCC) especially with Holiday shopping season.
 - With no auction, there are special things that used to be available that are still possible fundraisers; the Classroom projects, Teacher Experiences, and Book Signings. The plan is to try to incorporate these events in other areas: The Classroom Projects to be offered in a Silent Auction during Art Night; Teacher Experiences either to be silent auctioned during International Night or to be offered in an online auction; Book Signings to be offered during the Spring Book Fair.

Treasurer's Report: Phil Lucido, Treasurer

- Presented proposed budget changes to the membership. This included the purchase of a new sound system and monitor, and the inclusion of budget lines for National History Day.
 - Approval of including budget lines for NHD funds raised by teachers and students.
 - Approval of buying sound system for approximately \$1600. Will look into
